Secretary's report	<ul style="list-style-type: none">Minutes from the meeting last month were distributed via email. Terry made a motion to approve the minutes. Dave seconded. Motion approved.
Concession's report	<ul style="list-style-type: none">Dave Hilger reported that the first sport event date is 3/11. The building won't be dewatered by then. No running water, no cooking. Need to wait for weather to break. Possibly could sell cold drinks, Keurig, candy, & pretzels. Subsequent dates are 3/16 & 3/20. Might be ready by 3/20. Dave will be out to inventory what's on hand. Will need \$500-1,000 to start up with initial Pepsi order etc. Not sure about lacrosse and track restrictions due to COVID. Have plenty of water, hot chocolate, & coffee.
Treasurer's report	<ul style="list-style-type: none">Jim Blair reported 1099s were sent to the accountant. He's closer to reconciling the credit cards. Has been working through getting them where they need to be. Fiscal year end 2020 tax returns being finalized. Will have bad debt to write off.Conversation about outstanding amounts due from families: Directors received statements about unpaid family fees. They are working through collection. Past issue with uncashed family checks for uniform dry cleaning. Unable to collect from families no longer in the program.Pride Day funds: Need to contact Rick Hall about getting Pride Day funds into bank account.

President's report	<ul style="list-style-type: none">Terry asked the directors to continue to reach out to families about past due fee balances. Boosters were informed last year that they cannot approach families about fee collection. Boosters must depend on directors. We know you are working on it. Keep doing what you're doing. We are grateful.

They are learning a lot. Currently, creating ensemble groups. She has lists of students who are interested. Will resemble solo/ensemble events. Targeting April. OMEA will be virtual in March.Update on outstanding fees: 14 of the 31 students on her list are no longer part of the program. She is doing what she can to reach them.Next year: Students currently scheduling for next year's classes. Next year will be a rebuilding year for incoming freshmen. Currently, only 8 SMS hybrid students. Rest in CDL.

Parent who drives for a busing company offered to explore cost to bus students to Fairfield. Cost is \$35 per student. Exploring incorporating that cost into the budget.
- Next year: Chamber Singers auditions 3/1-5. Show choir on 3/5. Advanced women's chorus will not require audition next year. Wants to make program accessible because of CDL.
